The Skagit County Recreation & Event Center (Phase I) is well underway. Funding has been secured for the following projects:

- New restroom / concession stand facility at the Skagit Valley Playfields Softball Complex
- Covering of four (4) Joan Armstrong Tennis Courts

The Skagit Community Foundation has established a special fund “to cover the remaining two (2) Joan Armstrong Tennis Courts”. The principle donor has agreed to a “2:1” match up to \$200,000 on contributions from individuals and organizations. The maximum donor’s contribution will be \$400,000. Funds in excess of cost of covering courts will be used for other improvements to the tennis court facility.
